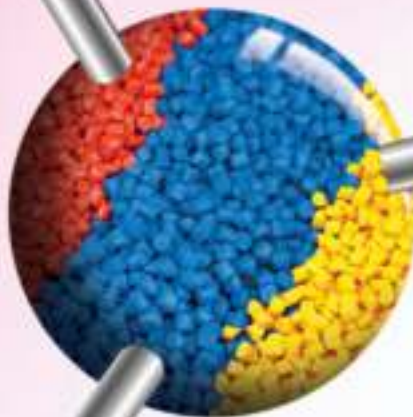

Third largest consumer of polymers

Total exports of dyes and dye intermediates, organic and inorganic chemicals, including agro chemicals, cosmetics and toiletries, essential oils, incense sticks and castor oil, stood at **US\$ 28.38 billion during the year 2017-18.**

The petrochemical market in India is expected to grow at a CAGR of 10 percent over the **next 5 years to reach US\$100 billion by 2022.**

Chemical sector to double by 2025 to reach US\$ 300 billion, clocking an annual growth rate of 8-10 per cent.

The US, the UAE, the UK, Bangladesh and Saudi Arabia are the leading importers of cosmetics, toiletries and essential oils.

India's vision to become a USD 5 trillion economy by 2025-26, including USD 1 trillion in manufacturing, would further boost the chemicals sector.
